La seconda attività è stata fatta alla Scuola Nautica Pro, abilitata dal Ministero dei trasporti spagnolo a rilasciare titoli con certificazione sulle competenze STCW, equiparabili quindi a quelli rilasciati in Italia dalla scuola in cui opero. La terza di job shadowing svolta in contesto informale, relativa alla cultura ed alla storia di Palma di Maiorca, è stata tenuta dal formatore in lingua inglese ad un secondo gruppo di 8 alunni. La quarta attività è stata quella relativa al job shadowing con un formatore esperto di tematiche relative alla Sostenibilità ambientale e dell'Ecologia che ha tenuto una lezione in lingua inglese e in contesto anch'esso informale ad un gruppo di 8 alunni. La quinta ed ultima delle attività di job shadowing cui ho partecipato si è svolta in contesto laboratoriale: gli studenti sono stati seguiti dal docente nella preparazione di prodotti artistici usando una tecnica che era stata precedentemente presentata durante lezioni teoriche.

Durante la mia esperienza di job shadowing ho acquisito preziose informazioni sulle sfide legate allo svolgimento di una lezione in una seconda lingua, in particolare l'inglese. Questa esperienza mi ha fornito le conoscenze necessarie per implementare efficacemente la metodologia CLIL nella mia materia in futuro.
